# Preparation

- Substrate requirements
  - Joint areas must be dry.
  - Protect ungrouted exterior surfaces from rain.
- Substrate preparation
  - Clean excess adhesive from joints.





#### Production of the mixture





#### Mixin

Pour water into a clean container and add dry mortar. Mix thoroughly with a mixer for approx. 3 minutes until homogeneous.

#### Directions





#### Conditions for use

Temperature of the material, air and substrate: from min. +5 °C to max. +30 °C. Low temperatures increase, while high temperatures decrease the working and setting time.

## ■ Working time (+20 °C) Approx. 60 minutes

Use a foam rubber scraper/grouting scraper to apply the grout over the entire surface and press into the joints. Level off sharply and remove excess material.

Use a slightly damp sponge to remove grout residue after it has set.

## Tips on use

Once it has hardened, mortar must not be made workable again by adding either water or more wet mortar.

Do not use on areas directly exposed to sunlight or on heated surfaces.

Touch the material to determine whether it has hardened sufficiently and is ready for washing.

Keep the amount of water used for cleaning to a minimum.

Always use clean water for the final cleaning process.

Clean with a damp sponge, not a dry cloth. There is a risk of discolouration due to rubbing the dried grout into the joints while they are still wet.

Protect the material from drying too quickly.

Minor colour variations are possible. Where possible, only use grout with the same batch number for the same project.

On polished fine stoneware, colour pigments can settle into any micropores present in the surface of the tiles. A strong colour contrast between the tiles and joints is therefore not advised. Set up a trial area if necessary.

### Notes

Low chromate content in accordance with Directive 2003/53/EC.

The characteristic data of the product were calculated under laboratory conditions at 20°C and 65% relative humidity.

The mixing water must be of drinking water quality.

May contain traces of pyrite (iron sulphide).

The level of moisture in the substructure and the ambient conditions affect the hardening process and the colour brilliance.

Light colours that are easily affected by dirt should not be used on floors.

Deviations from applicable regulations must be agreed separately.

The relevant test certificates must be observed when planning and carrying out work.

### Tools / Cleaning



Mixing tool, rustproof trowel, grouting board, sponge float, sponge

Clean tools with water while the material is still fresh.

## Storage / Shelf life



If stored in an unopened container and in a dry place, the product will keep for approx. 12 months.
