 Combi-container Add the entire quantity of the hardener (component B) to the base compound (component A). Mix thoroughly with a slow-speed electric mixer (approx. 300 - 400 rpm). Pour the mixture into a separate container and mix again thoroughly. Mix for at least 3 minutes. Insufficient mixing is indicated by streaks forming. Primers must always be applied so that all pores are filled; it may therefore be necessary to increase the application rate or to apply a second coat. Wetting problems are possible on non-absorbent or slightly hydrophobic substrates. In this case, the priming must be repeated a second time. The end of the pot life cannot be recognised by increased viscosity or temperature, thus the max. working time must be strictly observed. Abrasive mechanical loads leave traces of wear.
